ORDER:

In the Government order first read above, the following allowances have already been sanctioned to the Government Doctors

- i. Non Practicing Allowance
- ii. Other Compensatory Allowance
- iii. Rural Allowance
- iv. Equipment Allowance
- v. Overcoat Allowance
- vi. Leprosy Allowance / Special Leprosy Allowance
- vii. Post-mortem Allowance

2. Based on the request made by the Tamil Nadu Government Doctors Association for giving time bound promotion and sanction of certain allowances to the Medical Officer in Tamil Nadu Medical Service, the Government have constituted a committee to look into promotional opportunities of Government Doctors at various levels, headed by the Special Secretary to Government, Finance Department. In the Government Order second read above the Committee has submitted its main report on 04.08.2009 by recommending the time bound promotion to the Medical Officer in Tamil Nadu Medical Service. After detailed examination of the recommendation of the committee and orders were issued in the Government Order third read above. The Committee also submitted a Supplementary Report relating to allowances to the Government doctors on 12.09.2009.

3. The Committee has recommended to sanction certain allowances to the Government Medical Officer in Tamil Nadu Medical Service. After detailed examination of the supplementary report submitted by the Committee, the Government have accepted certain recommendations and sanctioned the following allowances to the Government Medical Officer in Tamil Nadu Medical Service in the Government order fourth read above

- i. Two additional increments to Super Speciality Doctors.
- ii. Primary Health Centre Allowance
- iii. 24 hours Duty Allowance
- iv. Non-practicing Allowance for High Level Officers (Joint Director and above)

4. On certain recommendations of the Committee, the remarks of the Heads of Department were obtained. After getting the remarks of the Heads of Department and detailed examination, it has been decided to sanction the certain allowances to the Government Medical Officers in Tamil Nadu Medical Service. Accordingly, the Government do and hereby direct that the following Special Casual Leave/Other Duty/Allowances be sanctioned to the Government Medical Officers in Tamil Nadu Medical Service.

- i) Grant of Special Casual Leave to the Principal author in the cadre of Assistant Professor, for paper presentation.
- ii) Treat the Medical Officers examinership to other Universities as "Other Duty"
- iii) Sanction the allowances mentioned in Column 2 as detailed in Column 3 in the Table below.

S. No. (1)	Type of Allowances (2)	Proposal of this department (3)
1.	Specialist Allowance for Diploma/Degree/Super Speciality.	Sanction of one increment for all Diplomas
2.	Primary Health Centre Allowance – enhancement (PHC)	Sanction of additional 50% allowance for those posted in 72 PHCs in difficult and remote areas approved by Government of India.

3.	Call Duty Allowance (DMS/DME)	Sanction of Rs.200/- per call duty to a maximum ceiling of Rs.1,000/- subject to the condition that no official vehicle including ambulance is used to bring the doctors to the hospital. (This allowance will be reviewed after one year, and if it is seen that it has led to doctors refusing call duty, then should be withdrawn after one year)
4.	Conference Allowance (DME)	Sanction of Conference Allowance may be allowed, if found mandatory as "on duty" with TA/DA, if not provided by the organizers.
5.	Mobile Allowance – in Closed User Group (DME/DMS/DPH)	Sanction of Rs.50/- as Mobile Allowance to the Medical Officers per month.
