ORDER:

In the reference read above, The Mission Director, State Health Society has stated that, the Government of India have informed that transfer of Central funds under the Centrally sponsored Schemes like NHM through the Treasury route as part of the State plan and requested to provide for Central Share of NHM in the state Budget. It has been informed that the Sharing Pattern between Govt. of India and the Govt. of Tamil Nadu, is revised at 60:40 from the Financial Year 2015-16

2. Govt. of India have transferred and credited into State Government account its 60% share of Grants in Aid for the financial year 2015-16 towards Release of 2nd Instalment of Grant-in-Aid(SCSP) under National Leprosy Eradication Programme for the year 2015-16

3. Further, Government of India has requested to ensure 40% State contribution based on the release of funds by Government of India.

4. The corresponding 40% of the State Share against the 60% of the Government of India release of **Rs.5,23,000/- (Rupees Five lakh and twenty three thousand**

only) works out to **Rs. 3,48,667/- (Rupees Three lakh forty eight thousand six hundred and sixty seven only).**

5. Since Government of India have transferred the grants to State Government for drawal of amount through Treasury route, the amount of State share will have to be drawn from State Budget.

6. Hence in order to implement the schemes under above said programmes during 2015-16, The Mission Director, National Health Mission has requested the Government to issue orders for the release of a sum of **Rs. 8,71,667/- (Rupees Eight lakh seventy one thousand six hundred and sixty seven only)** towards the release of Central and State Share contribution of grants in aid to the State Health Society under Release of 2nd Instalment of Grant-in-Aid to Tamil Nadu under National Leprosy Eradication Programme for the year 2015-16 and to authorize the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of **Rs. 8,71,667/- (Rupees Eight lakhs seventy one thousand six hundred and sixty seven only)** under National Health Mission through Treasury mode and credit into State Health Society Account.

7. The Government after careful consideration have decided accept the above proposals of the Mission Director, State Health Society and accordingly sanction a sum of **Rs. 8,71,667/- (Rupees Eight lakhs seventy one thousand six hundred and sixty seven only)** towards the release of Central and State Share contribution of grants in aid to the State Health Society under Release of 2nd Instalment of Grant-in-Aid(SCSP) to Tamil Nadu under National Leprosy Eradication Programme for the year 2015-16.
